- **1. The Appellant Mr. Surendra Govekar by his application dated** 23/11/2013 filed under section 6 of RTI Act 2005 sought information in the form of chart related to NOC for Electric connection and NOC for water connection issued by the Anjuna-Caisua Panchayat from 28/05/2012 to 23/11/2013 to various applicant.
- 2. Since the Respondent No. 1 PIO failed to reply the same and furnish the information, the appellant after exhausting his first remedy u/s 19 (1), approached this Commission by way of second appeal u/s 19 (3) on 14/05/2014.
- **3.** In pursuant to the notice issued by this Commission, Appellant was present in person. The present PIO Shri Dharmendra Govekar appeared during the hearings. On behalf of Respondent No.2 FAA Shri Rajkumar Chodankar appeared only once and then opted to remain absent.
- 4. Respondent PIO during the hearings showed his willingness to provide information to the Appellant and accordingly during subsequent hearing he furnished the required information to the appellant .
- **5.** The appellant after verification of the information submitted that the present PIO was very co-operative and have furnished him information which is to his satisfaction and requirement as such he has no grievance against present PIO Shri Dharmendra Govekar. He further submitted that since then PIO Babu Shirodkar has expired in the year 2015, he is not insisting for invoking penal provisions. Accordingly he endorsed his say on the reverse of the last page of his appeal memo.

- 6. Since the information has been now furnished to the appellant and view of submissions and the endorsement made by the appellant, nothing survives to be decided in the present appeal.
- 7. Appeal stands disposed accordingly. Proceedings stands closed.
