## <u>O R D E R</u>

- 1. This is the second appeal filed by the appellant Smt. Nalini Parab on 15/10/2015 u/s 19(3) of Right to Information Act interalia seeking the direction as against the PIO , office of the Mamlatdar of Pernem Taluka to furnish the copy of the affidavit annexed to the application for the residence certificate Number 24012013467/1161 dated 24/01/2013 of Late yashwant Vithu parab.
- 2. On issuing notices to the parties, the appellant appeared along with her son. Respondent No. 1 PIo Shri Ishan Sawant was present along with ex Talathi of MamItdar Office Shri Sanjiv Signapurkar.

- Affidavit duly notarized before executive Magistrate Tiswadi Taluka dated 08/02/2017was also placed on record by the Ex-Talathi Sanjiv A. Signapurkar. The copy of the same was furnished to the appellant.

The appellant then on subsequent date submitted that the information which have been furnished to her by the PIO is to satisfaction and as per her requirement as such now, no any grievance against Respondent. Accordingly she endorsed her say on the last page of memo of appeal and prayed for the disposal on the proceedings.
