ORDER

1. Brief facts of the case are that the appellant herein Shri Deepak Sahasarebudhye filed an application dated 11/11/14 to PIO office of the Mamlatdar, Bicholim, Goa in respect of survey No. 3/5 situated at Village Venguem Goa on two points for the period 1993, to which reply was filed by Respondent NO. 1PIO on 21/11/2014 wherein the Xerox copy of the records to the tenancy case No. TNC/V/Belgaum/11/93 was furnished to him.
2. Since the certified copy of the registered postal acknowledgement copy signed by Shri Ganapat keshav Sahasarebudhye, Belguem was not furnished to him the appellant approach this commission on 27/12/14. With a prayer for direction as against Respondent PIO for furnishing the require information to him.

3. In pursuant to the notice appellant appeared in person Shri madhu Narvekar appeared on behalf of Respondent No. 1 PIo.
4. During the hearing appellant submitted that he had not made first appeal as he was not knowing who was the First appellate authority and that he had made appeal before settlement and land records, panajim, Goa and the said appeal was not entertained by them
5. Reply came to be filed on behalf of PIo On 29/9/2016.
6. The Respondent NO. 1 during the hearing informed that the certified copy of the postal acknowledgment and the cash paid receipt are not available in their records. The respondent No. 1 PIo showed his willingness to further search the records to see whether the information is available. The appellant also agreed to visit the office of the Respondent to inspect the documents .
7. A compliance report also came to be filed by the Respondent PIo on 3/1/17 enclosing the acknowledgments of the appellant of having inspected the inward and outward registered maintain in their office with effect from 8/12/1993, The Respondent submitted that Prior to 8/12/93 the records are not available with their office. The appellant who is present also confirm that he has gone to the office of the respondent and verified the records with effect from 8/12/93 on 14/12/2016. The appellant submits that he is satisfied with the information provided to him as per the available records provided to him.
8. Since the available information is provided to him nothing survives to be decided in the present matter. Appeal disposed accordingly proceedings stands closed.
