ORDER

- 1. Brief facts leading to present appeal are as under:-
 - By an application dated 01/02/2016 the Appellant Shri Yogesh Roythetia sought certain information from Respondent No. 1 Public Information Officer (PIO), Goa State Commission for Women regarding the documents filed by one Mrs. Sudha Naik in case No. 3/2959/2014 with them.
- 2. According to the appellant the said was not furnished to him as per his requirement as such appellant after exhausting his 1st remedy under section 19 (1) of Right To Information Act (RTI Act) approached this Commission by way of 2nd Appeal under section 19(3) of RTI Act with prayer for directions as against Respondent No. 1 PIO for furnishing required documents to him as sought by him vide his application filed under section 6(1) of RTI Act.

- 3. In pursuant to the notice of this Commission, the Appellant appeared in person. Respondent No. 1, PIO was represented by PIO Shri Siddhi Vinayak Naik.
- 4. It was contention of Respondent No. 1 PIO that in pursuant to their various intimation letters, the appellant had collected the information on 11/08/2016. However according to appellant, complete information was not provided as such. The PIO again showed his willingness to furnish him the required documents and accordingly same was furnished to the appellant on 06/03/2017. The Respondent PIO also submitted that besides the above documents, there are no any other documents available in their records.
- 5. Appellant on going through the said reply and information submitted that with this information, his application dated 01/02/2016 filed under section 6(1) of the RTI Act, stands fully replied and he is satisfied with the information provided to him as such he doesnot insist on penal provisions and doesnot desire to proceed with the appeal.
- 6. Since information have been received by appellant as per his requirement and inview of the submissions made by appellant, nothing survives to be decided in present appeal.
- 7. Appeal stands disposed accordingly proceedings stands closed. Notify the parties.

Aggrieved party if any may move against this order by way of a Writ Petition as no further Appeal is provided against this order under the Right to Information Act 2005.
