## ORDER

- 1. This is the second appeal filed by the appellant Shri Prawas R. Naik u/s 19(3) the RTI Act 2005 on 14/06/2016 interalia seeking the direction as against respondent No. 1 PIO, Assistant Director of education Department, Sanguem to furnish the information as sought by him vide his application dated 9/2/16 and for invoking penal provisions.
- 2. In pursuant to the notice the representative of the appellant Miss. Sudhiksha Naik appeared. Respondent No. 1 then PIO Shri Uday Dessai was present along with present PIo Suresh Lotlikar, on behalf of Respondent No. 2 Shri Dayanand Chaudikar appeared.

- 3. The copy of the information at serial No.(a) that is enquiry report dated 15/12/2015 has been furnished to the representative of the appellant in the course the hearing. The Respondent PIO submitted that the information pertains to point (b) and (c) have been in corporate in the information provided at point No. (a). The Respondent No. 1 PIO further submitted that then PI O Shri Uday Dessai has been retired from services.
- 4. On verification of the information , the representative of the appellant submitted that she is satisfied with the information provided to her and as the then PIO Shri Uday Dessai has retired from services and the appellant is still working in the same institution and in order to maintain cordial relationship with his collegues she desires not to press for penal action as against the present PIO and then PIO. Accordingly she endorsed her say of the last page of memo appeal and prayed for the disposal on the proceedings.
- 5. In view of the submission of the representative of the appellant and the endorsement made by her and as the information furnished to her, to her satisfaction, and as per her requirement nothing survives to be decided in the present appeal.
- 6. The appeal disposed accordingly with a liberty to the appellant to seek any further information pertaining to the same subject matter if he so desires.

The proceedings stands closed.
