ORDER

1. The brief facts leading to the present appeal are as under :-
 That the appellant , vide his application, dated 9/6/2017 addressed to the Public Information Officer (PIO), Administrator of Comunidade, North Goa at Mapusa Bardez Goa, requested to furnish certain information at point 1 to 3 as stated by him in the said application with respect to publication of notice on the Government Gazette in series III No. 7 dated 18/5/2017 with respect to plots at Assgao in the property bearing survey No. 145/1-E. of Assgao Village Bardez Goa. The same was sought u/s 6(1) of Right to information Act , 2005.
2. According to the Appellant the Respondent PIO did not furnish him the information which was sought for and not

responded his application as such he filed appeal before the first appellate authority on 20/7/2017 .

3. The First Appellate Authority (FAA), by an order, dated 17/8/2017 allowed the appeal of the Appellant and the Respondent PIO was directed to furnish the information sought by the appellant free of cost within a period of 10 days from the date of the receipt of the order.
4. It is the case of the appellant the despite of the order of First Appellate Authority, PIO failed to provide him information as such Being aggrieved by the action of the respondent, the appellant approached this Commission on 22/09/2017 by way of second appeal filed u/s 19(3) of the Right To Information Act on the grounds as raised in the memo of appeal. In the present appeal the appellant has prayed for directions to the PIO to furnish him the required information and also for invoking penal provisions.
5. The matter was taken up for hearing on 3/10/2017 at the request of the appellant . The Respondent was represented by Shri Ramesh Tulskar who in the course of the present proceedings furnished the information to the appellant.
6. The appellant then on going through the said information submitted that with this information his application dated 09/06/2017 filed u/s 6(1) of the Act, stands fully replied and hence does not desire to proceed with the appeal. Accordingly appellant endorsed his say on the memo of appeal.

7. In view of the submissions and endorsement made by the appellant , I find no reason to proceed with the matter.

Appeal disposed accordingly. Proceedings stands closed.
