ORDER

- 1. Brief facts leading to present appeal are as under: the appellant Shri J. T. Shetye by his application dated 3/01/2017 sought certain information on 5 points from the PIO Deputy Collector, Bardez, Mapusa with reference to representation dated 25/11/16 made by him.
- **2.** According to the appellant the application dated 3/1/17 which filed under 6(1) was not responded by Public Information Officer (PIO) as such he preferred the 1st appeal before the Respondent No. 2, Additional Collector-I, North Goa, being First Appellate Authority (FAA) on 10/02/2017.
- **3.** According to the appellant the Respondent No. 2 issued notices to him and hearing were taken on 3 occasion despite failed to passed an appropriate order within stipulated time.

- **4.** As both the Respondent did not adhere to his request for furnishing the information and being aggrieved by the action of both Respondents, have approached this Commission on 7/04/17 with the prayer to penalise Shri Chandrakant Shetkar, then PIO u/s 20(1) of RTI Act and for initiating disciplinary proceedings. Vide said appeal he has also sought for the relief for implementation of section 4(1)(a) and 4(1)(b) of Right to Information Act.
- **5.** In pursuant to notice of this Commission appellant was present in person. APIO Shri Keerti Kumar Bandodkar was present who filed reply on 4/09/2017. Shri Gaurish Sankhawalkar also appeared during subsequent hearings.
- **6.** As undertaken by the present PIO, the information was furnished to appellant by Registered A. D.
- **7.** On subsequent date of hearing on 16/10/2017 the appellant appeared in person and submitted that he has received information by post and it is to his satisfaction and requirement.
- **8.** He showed his desire to withdraw the same and accordingly made his endorsement on the last page of memo of appeal.
- **9.** In view of his submissions and the endorsement made by him I find no reason to proceed with the present matter.
- **10.** Appeal dispose as withdrawn proceeding stands closed.
