**ORDER**

1. By an application dated 27/11/2014 filed under section 6(1) of the RTI Act Appellant Shri Xavier Dias has sought certain information from Respondent No. 1, Public Information Officer (PIO), O/o. Dy. Collector and SDO, Salcete, Margao- Goa.
2. Since the said application was not responded by the PIO, the Appellant preferred 1<sup>st</sup> appeal on 19/01/2015 before the Additional Collector-I South Goa District, Margao-Goa being First Appellate Authority (FAA) and FAA by an order dated 10/02/2015 directed the Respondent No. 1 PIO to provide copy of the Roznama of the case bearing No. LRC/DEM/Govt/29/2014 –I within 15 days from the receipt of the order.
3. Despite of the order of FAA since no information was furnished to him a reminder letter were send by the Appellant to the Respondent No. 1 PIO on 02/04/2015. The same was also not Responded, the Appellant being aggrieved by the action of Respondent No. 1 PIO landed up before this Commission by way of second appeal under section 19(3) of the RTI Act on 24/04/2015.
4. In pursuant to the notice appellant was present in person Respondent No. 1 was represented by Viraj Malkarnekar. Reply filed on 06/03/2017 there by provided information on 2 points as sought by the Appellant vide his application dated 27/11/2014 . The copy of the reply/ information was provided to the Appellant during the hearing. After verification of the said information the Appellant submitted that he is satisfied with the information provided to him and he prayed for disposal of the appeal.
5. Since information is provided to the Appellant to his satisfaction and in view of his submission and endorsement made by him in memo of appeal nothing survives to be decided in the present appeal.
6. Appeal is disposed off proceeding stands closed.

Aggrieved party if any may move against this order by way of a Writ Petition as no further Appeal is provided under the Right to Information Act 2005.
