## **ORDER**

1. Brief facts leading to the present appeal are as under:-

the appellant Shri Bavikara Abdulla Mohammed by his application dated 18/10/16 sought certified copies of Traces for the financial year 2013-14 in respect of Bhavikara Construction private Ltd. from PIO , work DIV XIII (R), Public works Department Mapusa Goa.

2. Since the application was not responded by Respondent No. 1 PIO, he preferred first appeal with Superintending engineer PWD Panaji who is the Respondent No. 2 herein. Who by on order dated 16/1/17 allowed the appeal of the appellant and directed Respondent PIO to furnish all the information sought by the appellant within 10 days free of cost .

3. Since the order of the Respondent No.2 First appellate authority was not complied by the Respondent No. 1 PIO , the appellant approached this commission by way of second appeal on 3/2/17 thereby seeking direction as against Respondent No. 1 PIO for providing him correct information free of cost, for inspection of files records and for invoking penal provisions.
4. In pursuant to the notice of this Commission, the appellant was present along with Advocate Aatish Mandrekar. Respondent No. 1 PIO Shri Atmaram Gawade was present who filed his reply on 19/6/2017 thereby contending that the due information have been furnished to the appellant on 5/6/2017 as per the directions of this Commission .

The advocate for the Appellant also confirmed of having received information as per their requirement and prayed for disposal of the matter. Accordingly he endorsed his say on the memo of appeal.

5. In view of submission and endorsement made by the Advocate for the appellant nothing survives to be decided in the present matter.
