## **ORDER**

1. The brief facts of the present appeal are that the appellant Shri Rohan Shirodkar by his application dated 09/3/15 had sought for report of site inspection conducted by inquiry committee of GCZMA dated 19/9/14 in respect of property owned by the Department of Fisheries, Government of Goa in Survey No. 62/0 of village Malim , Penha france, Bardez, Goa from PIO, Goa Coastal Zone management authority panajim, Goa .
2. The said application was not responded by Respondent NO. 1 PIO as such deeming the same as rejection , the appellant preferred first appeal on 6/5/15. The first appellate authority dismissed the said appeal and closed the proceedings without hearing the appellant.
3. Being aggrieved by the order of the First appellate authority the present appeal came to be filed before this commission by the appellant on 22/7/2015 u/s 19(3) of the RTI Act 2005 with a prayer for direction as against Respondent PIO for furnishing him the required information and for invoking penal provision.

4. In pursuant to the notice of his commission the Appellant was represented to Advocate A. kale Respondent No. 1 PIO. Shri Sanjeev Joglekar was present. He submitted that at the relevant time when the application was made u/s 6(1) the said information was not available with them and the report issued by the inquiry committee dated 5/6/17 have been submitted to them recently. Accordingly he furnished the said information to the Advocate for the appellant on 8/6/17 alongwith the annexures .
5. The Advocate for the appellant on going through the said information, submitted that with this information the application of the appellant dated 9/3/15 filed u/s 6(1) of RTI Act 2005, stands fully replied and that the information which came to provided to now, is as per requirement of appellant. She further submitted that she is not pressing for penal provisions and prayed for the disposal of the matter. Accordingly she endorsed her say on reverse of a memo of appeal.
6. In view of the submission and endorsement made by the Advocate for appellant, nothing survives to be decided in the present matter.

Appeal disposed accordingly . Proceedings stands closed.
