ORDER

- 1. The brief facts of the case are that the second appeal came to be filed by the appellant Shri Ravindra Velip u/s 19(3) of the RTI Act,2005 before this commission on 27/11/14.
- 2. It is the case of the appellant that he had sought information from the PIO, Collector of Quepem Goa on 5 points as stated therein in the said application .
- 3. The said was responded by the PIO on 25/6/14 thereby intimating the appellant that the requested information is not available in their office.
- 4. Being aggrieved by the reply of the Respondent PIO, the appellant then preferred first appeal before the Add. Collector-I at Margao on 25/7/14 and the First appellate authority disposed the same on

27/8/14 thereby giving directions to the PIO to give the inspection of record to the appellant on 4/9/2014 at Quepem S.D.M office.

5. It is the case the appellant that though the PIO allowed him to inspect the documents did not produce all the documents before him for inspection and also did not furnish him the documents which he had sought vide his RTI Applications ,as such he had to approached this commission on 27/11/2014 by way of 2nd appeal to seek appropriate relief.

6. In pursuant to the notice of this commission appellant was present in person on behalf of Respondent No. 1 Peter Azavedo was present.

7. During the hearing on 29/6/1017 appellant submitted that his main object was to get the information and not to penalize any officer and since now the entire information has been received by him he is pressing for cost. As such he prayed for the disposal of the present appeal. The appellant also endorsed his say on last page of memo of appeal.

8. In view of submission of the appellant and the endorsement made by him nothing survives to be decided in the present appeal.

Appeal disposed accordingly proceedings stands closed.
