ORDER

1. The appellant Smt. Betty Alvares herein by her application, dated - 3/9/2014 filed u/s 6(1) of the Right to Information Act, 2005(Act) sought certain information from the Respondent No. 1, PIO RCS Office, Panaji, Goa under several points therein.
2. The said application was replied on 29/9/2014. Being not satisfied with the reply, the appellant preferred first appeal before the registrar of Co-operative Societies being first appellate authority who is Respondent No. 2 herein on 3/10/2014 .

3. The Respondent No. 2 First appellate authority by an order dated 22/1/2015 dismissed the appeal on the ground that the available information already furnished to the appellant .
4. The appellant has therefore landed before this commission on 28/1/2015 in this second appeal u/s 19(3) of the RTI Act 2005
5. Notice were issued to the parties. The Notice issued to the applicant return unserved, with endorsement " party left return to sender". the Respondent no. 1 PIO was represented by Shri P.A. Porab who filed reply on 15/03/2017.
6. In the course of the hearing PIO showed his willingness to furnish the information once again to the appellant and he sought time for locating/tracing present address of the appellant .
7. On subsequent date hearing he submitted that the information which was sent by him by registered A.D. on Goa Address has returned with as endorsement 'unclaimed'. He further submitted that information to appellant is also being sent him on Mumbai address. However he submits that they have still not received acknowledgment card accordingly he filed compliance report on 15/03/2017.
8. In view of above given circumstances the commission fills it necessary to keep the said information in the file so that in case the appellant approaches this commission the information could be handed over to him.
9. The other prayers which are the in penal nature cannot be entertained as the appellant did not appear this commission to substantiate his case.

The appeal is disposed accordingly.

Proceedings stands closed .
