- 1. The Appellant, Shri Shrikant S. Vengurlekar has filed the present appeal u/s 19(3) of RTI Act, 2005 on the ground that the Respondent No. 1 PIO of the office of Directorate of Education furnished him only the part of the information on 18/12/2017 which was sought by him vide his application dated 6/12/2017. It is his specific grievance that information at point no. 6 was partly provided to him. He also relied upon the supporting documents more specifically letter dated 18/12/2017 of the PIO by with the said information came to be furnished to him. In the present appeal the appellant has sought direction as against Respondent PIO for furnishing complete information at point no. 6.
- 2. In pursuant to the notice of this commission, the appellant appeared in person. Respondent No. 1 PIO Shri Ishwar Patil present and Respondent No. 2 represented by Shri Dayanand Chawedkar .

- 3. In the course of the hearing the appellant submitted that the information at point No. 6 is partly provided to him and the date on which the said order is posted to him have not been furnished. He further contended that the same is required to submit it before the Hon'ble High Court .As such the respondent was directed by this Commission to verify their records and provide the said information to the appellant.
- On subsequent date of hearing i.e. on 29/1/2018 the respondent PIO furnished complete information with regards to point No. 6 as sought by the appellant vide his application dated 6/12/2017.
- 5. On verification of the said information the appellant submitted that with the said required information , his application u/s 6(1) have been completely answered and he satisfied with the information furnished to him and he prayed for disposal of the present appeal. Accordingly he endorsed his say on memo of appeal.
- 6. In view of the submission and endorsements made by the appellant I find no reason to proceed with the appeal.

Accordingly appeal disposed proceeding stands closed.
