ORDER

- 1. The brief facts of the present appeal are that the appellant Shri Sanjay K. Phatte by his application dated 24/7/2017 has sought for certain information from the Respondent No. 1 PIO of the office of Assistant of Registrar of co-operative Societies, Central Zone Panajim, in respect of Shri Chandran T. P., Special Auditor of the State Registrar of co-operative Societies
- 2. application was responded by the Respondent Public The said Information Officer (PIO) on 20/8/2017 thereby denying the information to the appellant on the ground that there is likelihood to conflict the public interest.
 - 3. Being not satisfied with the reply of respondent PIO the first appeal came to be filed by the appellant before the Registrar of cooperative Societies being first appellate authority and the first

appellate authority by order dated 3/10/2017 dismissed the same by upholding the reply of PIO.

- 4. Being aggrieved by the order of first appellate authority dated 3/10/2017, the appellant has approached this commission by way of present second appeal thereby seeking relief of directions as against Respondent PIO for furnishing the information and for invoking penal provisions .
- 5. The notices were issued to both the parties. In pursuant to which appellant and respondent PIO Shri Mahadev Kalangutkar were present.
- 6. In the course of the proceedings the appellant submitted that he is not interested in pursuing the present appeal and desire to withdraw the same as the information which was sought by him is no more useful to him. Accordingly he endorsed his say on the memo of appeal.
- 7. In view of his submission and endorsement made by the appellant, I find no reason to proceed with the matter. As such the appeal stands disposed as withdrawn.
