**"Taken up before CIC:**

Appellant alongwith his representative Shri Vaman Parab Korzuvekar presents. PIO represented by Shri. Damodar V Morajkar. FAA, Shri. Sudir Kerkar present. Shri. Kerkar certifies the roznama filed on the last date of hearing. Submission of the parties heard.

On considering the submissions and going through the records, it is seen that by application u/s 6(1) dated 08/12/2017 the appellant has sought the certified copies of the proceeding sheet with respect of cancelation and deletion of names of 5 persons, mentioned in the application, from the Colum of tenants

in respect of property under survey no. 58/1 of Arambol Pernem Goa.

As per the reply dated 05/01/2018, the PIO has informed that after obtaining the report of Talathi, it is found that the names of said 5 persons were deleted at the time of promulgation of the record. According to Shri. Morajkar, representing PIO, as the said names were deleted at the time of promulgation or prior thereto, such records will be available with the office of Directorate of Settlement and Land records (DSLRL).

Considering the said submission, I find that the PIO was required to transfer the said application, dated 08/12/2017 to the PIO of Directorate of Settlement and Land records (DSLRL), as contemplated u/s 6(3) of the act. However considering the fact that the information is not held by respondent authority and that it may be available with the office of Directorate of Settlement and Land records (DSLRL), Commission considers it appropriate to direct the PIO herein to transfer the said application to PIO Directorate of Settlement and Land records (DSLRL).

The PIO herein is therefore directed to transfer the application, dated 08/12/2017, to the PIO of Directorate of Settlement and Land records (DSLRL) within 5 days from the date of receipt of this order by it under intimation to the appellant. This appeal stands disposed accordingly. Notify the parties. Pronounced in the open hearing."
