## ORDER

- 1) Appellant and Respondent present. Respondent represented by Shri Dayanand Chawdikar. The Appellant filed an application today alongwith annexures, interalia praying that the Respondents be issued direction to furnish the particular as sought by the Hon'ble High Court of Bombay by letter dated 17/10/2015. The said letter dated 17/10/2015 issued by the Assistant Registrar, High Court of Bombay is annexed by the appellant to the said application as exibit G (colly).
- 2) The said application was replied by the Respondents by an endorsement over the same stating that the relief in terms of para (10) of the said application can be granted.
- 2) Parties were heard the appellant submitted that his entire exercise in seeking the information which is the subject matter of this appeal is to procure the service particulars for the purpose of settlement of his retirement dues. He further submitted that as per his representation to the Hon'ble High Court the Assistant Registrar has issued such directions to the Respondents to furnish the service particulars and in

case such particulars are furnished the present appeal would be

redundant as his purpose will be served. He further submitted that in

case this Commission directs the Respondents to comply with the

requirement of the Assistant Registrar vide said letter dated

17/10/2015 and accordingly furnishes the information, this appeal can

be disposed.

4) I have perused the said letter. It is seen that the Assistant

Registrar has request the directorate of education, which is the

Respondent No. 2 herein to verify and confirm the services rendered by

the Appellant as a Government Primary Teacher and to forward the

certified copy of the service book and order of appointment alongwith the

details as to whether the appointment was on regular basis or otherwise.

This information according to appellant would be sufficient information.

The Respondents submitted that it does not have any objection to

this Commission passing such direction.

In the aforesaid circumstances, I have no hesitation in passing 5)

such order as prayed for by the appellant. Accordingly, the Respondents

are directed to furnish to the Assistant Registrar of the Hon'ble High

Court of Bombay to forward the certified copy of his service book and

order of appointment as Primary Teacher alongwith the details as

directed by the Hon'ble High Court as per said letter HCB/GOA/MISC-

3/2015 dated 17/10/2015. The said records are to be submitted to the

Assistant Registrar in compliance of the said letter dated 17/10/2015.

6) In view of the above, as submitted by the appellant nothing

survives in the present appeal and accordingly the appeal stands

disposed off.

Pronounce in the open proceedings.
