The above four appeals pertain to one and the same Parties and as such they are combined together and disposed by one common order.

1. **BRIEF FACTS OF THE CASE**: The Appellant herein Shri Bharat L. Kandolkar has filed four separate Second Appeals before the Commission. All important dates including the date of filing the RTI application, date of the reply of PIO, date of filing the First Appeals, date of order of FAA and the date of filing Second Appeals before the commission are listed in tabulation form.

- 2. The main grievance of the Appellant is that despite the order of the First Appellate authority (FAA), directing the PIO to allow inspection and to furnish information, the same has not been complied and therefore the Appellant has approached the Commission u/s 19(3) by way of four Second Appeals and has prayed to direct the Respondent PIO's to furnish information as requested in the RTI Application, to provide inspection of the records, files, registers etc. and to impose penalty, disciplinary action and for other such reliefs.
- 3. **HEARING**: During the hearing the Appellant is represented by Adv. Atish Mandrekar whose Vakalatnama is on record. The Respondent PIO, Secretary, V.P Candolim is represented by Adv. Siddesh R. Prabhudessai whose Vakalatnama is on record.
- 4. **SUBMISSIONS**: Adv. Atish Mandrekar for the Appellant submits that he has carried out the inspection of the files and indentified the information and that the PIO has agreed to provide the information as identified. Adv. Siddesh R. Prabhudessai confirms that the Appellant has inspected the files and has identified the information and further submits that the PIO has kept the information ready and requests that the Commission may pass order directing the PIO to furnish the information documents as identified by the Appellant.
- 5. **DECISION:** As the Appellant is satisfied with the inspection and has identified the information which is confirmed by Adv. Siddesh R. Prabhudessai for the Respondent PIO, as such the Commission accordingly directs the Respondent PIO, Secretary, V.P. Candolim to furnish the information so indentified by the Appellant after inspection within 15 days of the receipt of the order i.e (latest by 05/12/2019).

# With these directions all the four Appeal cases stands disposed.
