**ORDER**

1. Brief facts of the case are that the Appellant Shri. Ulhas S. Diukar had filed second appeal before this Commission on 21 /01/2021.
2. Contention of the Appellant was that Public Information Officer (PIO) of Greater Panaji Planning Development Authority (GPPDA) did not provide information sought by him vide RTI application dated 29/09/2020. It was contention of the Appellant that First Appellate Authority (FAA) of GPPDA also did not pass any order on the first Appeal filed on 10/11/2021.

3. The contention of the Appellant is that aggrieved by the non furnishing of the information he has approached before the Information Commission. During the hearing today on 15/04/2021 at 11.00 a.m. Respondent PIO displayed the documents which were sought by the Appellant.
4. Advocate Snehal Rawool appearing on behalf of the Appellant inspected the said documents and endorsed her say on the appeal memo stating " I would like to withdraw the Appeal".
5. In view, of the endorsement given by the Advocate of the Appellant, Ms. Snehal Rawool, I find no reason to proceed with the present proceedings. Hence the Appeal proceedings stand disposed. The Appeal is withdrawn and the matter is closed.
