ORDER

1. The Second Appeal filed by Shri. Ranjit Raghvan under section 19(3) of the Right to Information Act, 2005 (for short, the Act) against Respondent No. 1 PIO and Respondent No. 2. FAA came before this Commission on 20/09/2021. Appellant was aggrieved as the information he sought vide application dated 24/06/2021 was not furnished to him and also, the appeal filed before FAA was not heard.
2. The concerned parties were notified and pursuant to the notice Appellant and PIO appeared in person. The Commission directed PIO to facilitate inspection of the records sought by the Appellant and

furnish the relevant information to the Appellant. Both the sides agreed to undertake inspection on 3/11/2021 at 10.30 a.m. in PIO's office. Later, PIO filed reply alongwith the enclosures, received in the Registry on 25/11/2021.

3. During the hearing on 01/12/2021 Appellant and PIO appeared in person. Appellant stated that the complete information is furnished to him by the PIO. Appellant endorsed the receipt of the information and requested the Commission for disposal of the matter.
4. As the information has been furnished, and Appellant has endorsed the same, nothing is left in this Appeal to be decided by the Commission. Hence the appeal is disposed accordingly. Order passed. Proceeding closed.
