ORDER

- 1) Aggrieved with the non-compliance of the order dated 28/09/2021 passed by the respondent no. 2, First Appellate Authority and non furnishing of the information sought vide application dated 02/08/2021, by respondent no. 1, Public Information Officer (PIO), the appellant preferred this appeal before the Commission.

- 2) The appeal was registered on 28/10/2021 and the concerned parties were notified. Adv. Deepak V. Naik and Adv. Ashvita Shanke appeared on behalf of the appellant. Shri. Allauddin Maniyar, PIO/Secretary, Village Panchayat Chinchinim-Deussua appeared before the Commission on 22/12/2021 and filed reply and undertook to furnish the entire information to the appellant.
- 3) During the hearing on 19/01/2022, legal representative of the appellant, Adv. Ashvita Shanke, whose wakalatnama is on record, stated that the PIO has furnished the information and the appellant prays for withdrawal of the appeal. Adv. Shanke registered the said request on the back side of the appeal memo with her signature.
- 4) As a consequence, the proceeding of this appeal become infructuous and the appeal is required to be disposed accordingly. Hence the appeal is dismissed as withdrawn and the proceeding stands closed.
