ORDER

- 1. The Appellant, Shri. Jawaharlal T. Shetye r/o. H.No. 35/A, Ward No. 11, Khorlim-Mapusa, Goa vide his application dated 15/06/2021 filed under Section 6(1) of the Right to Information Act, 2005 (hereinafter to be referred as 'Act') sought certain information from the Public Information Officer (PIO), Mapusa Municipal Council, Mapusa-Goa.
- 2. Since the said application was not responded by the PIO within the stipulated time, deeming the same as refusal, the Appellant filed first appeal before the Chief Officer, Mapusa Municipal Council on 22/06/2021, being the First Appellate Authority (FAA).
- 3. Since the FAA failed and neglected to hear and dispose the first appeal within the stipulated time, the Appellant preferred this Second appeal before the Commission under Section 19(3) of the Act.
- 4. Notices were issued to the parties, pursuant to which, the Appellant appeared in person on 31/03/2022, representative of

the FAA, Adv. Pallavi Dicholkar appeared and filed her reply on 19/07/2022, the PIO, Shri. Santosh Humraskar appeared and submitted that he is ready and willing to give the inspection of the record, the Commission accordingly directed the PIO to give the inspection of records and matter was fixed for compliance.

- 5. In the course of hearing today i.e. on 02/11/2023, the other PIO, Shri. Nilesh Lingudkar appeared and shown his willingness to provide the inspection of records. The Appellant J.T. Shetye appeared and submitted that he is now not interested for inspection of records as the said information become infructuous due to long lapse of time. He also submitted that he does not wish to proceed further with the matter.
- 6. On the basis of submission made by the Appellant, the matter is disposed off.
 - Proceeding closed.
