FACTS IN BRIEF

- 1. The Appellant, Shri. Pandhari P. Prabhu r/o. H.No. 882/1, Vaseru, Panchame, Priol, Mardol, Ponda-Goa vide application dated 11/05/2022 filed under the Right to Information Act, 2005 (hereinafter to be referred as 'Act') sought information on 8 points from the Public Information Officer (PIO), the Deputy Director (Administration), Principal Chief Conservator of Forests, Altinho, Panaji-Goa.
- 2. The office of Deputy Director (Administration), Principal Chief Conservator of Forests transferred the said application to the PIO, Deputy Conservator of Forests, Working Plan Division, Altinho, Panaji-Goa on 18/05/2022 requesting to furnish the information to the Appellant directly.
- 3. The PIO of the Deputy Conservator of Forests, Working Plan Division, Goa Van Bhavan, Panaji responded to the Appellant on 29/06/2022 in the following manner:-

- 4. Being aggrieved for providing part of the information and not satisfied with the reply of the PIO, the Appellant filed first appeal before the Conservator of Forests, Altinho, Panaji-Goa being the First Appellate Authority (FAA).
- 5. The FAA vide its order dated 03/08/2022 partly allowed the first appeal and directed the PIO to provided a modified / correct reply

- on point No. 3,5 and 7 and also directed to provide the copy of the order within 15 days.
- 6. Since the PIO failed and neglected to comply the order of the FAA dated 03/08/2022, the Appellant landed before the Commission by this second appeal under Section 19(3) of the Act.
- 7. Notices were issued to the parties, pursuant to which Appellant appeared in person on 06/12/2022. Representative of the PIO Shri. Dilesh Gawas Dessai appeared on 05/01/2023. The PIO filed his reply alongwith the bunch of documents through entry registry on 04/01/2023. Representative of the FAA, Shri. Jose Colasco appeared on 05/01/2023 and submitted that he does not want to file any reply in the matter. The copy of the reply alongwith the document has been furnished to the Appellant on 05/01/2023. The Appellant sought time to scrutinise the information provided by the PIO and matter was posted for clarification/ order on 06/02/2023.
- 8. Shri. Dilesh Gawas Dessai, APIO in the course of argument on 06/02/2023 pointed out that, upon the direction of the FAA, he supplied additional information at point No. 03, 05, 06 and 07 by modifying his earlier reply, which reads as under:-

According to APIO he complied the order of the FAA dated 03/08/2022 and furnished the modified reply and furnished complete information to the Appellant on 19/10/2022 and again on 05/01/2023.

- 9. Upon receiving the reply and information on 05/01/2023, the Appellant did not remain present for further hearings viz on 06/02/2023 and 24/02/2023 or rebutted the contention of the APIO. I therefore presume and hold that, the Appellant is satisfied with the information provided by the PIO. Accordingly the appeal is disposed off.
