ORDER

1. Being aggrieved by non furnishing of the information in spite of the direction by the First Appellate Authority (FAA), appellant under Section 19 (3) of the Right to Information Act, 2005 filed second appeal against Respondent Public Information Officer (PIO), which came before the Commission on 29/03/2023.
2. The concerned parties were notified, pursuant to which appellant appeared in person. Advocate Narayan R. Pai appeared on behalf of the PIO. During the hearing on 01/06/2023 Advocate Narayan R. Pai filed reply stating that he is furnishing complete information to the appellant and renders apology on behalf of the PIO for the delay. Appellant who was present in person, acknowledged receipt of the information. Further, appellant with his signature on the appeal memo requested the Commission to allow him to withdraw the present appeal in view of the receipt of information.
3. Upon perusal the Commission finds that, the information sought by the appellant vide application dated 04/01/2023 has been furnished, though after delay, for which PIO has apologised. Similarly, appellant after receiving the information has sought permission of the authority to withdraw the appeal. Hence, the Commission concludes that as the information has been furnished to the satisfaction of the

appellant, no more intervention of the Commission is required in the present matter.

4. Thus, the present appeal is disposed as withdrawn and proceeding stands closed.
