**ORDER**

1. The brief facts of this matter are that, the appellant had sought certain information under Section 6 (1) of the Right to Information Act, 2005 (hereinafter referred to as the 'Act') from Respondent No. 1, Public Information Officer (PIO). Being aggrieved by receipt of wrong information, he filed appeal before Respondent No. 2, First Appellate Authority (FAA). The said appeal was disposed vide order dated 13/05/2022. However, not satisfied with the information provided and FAA's order appellant approached the Commission by way of second appeal.
2. Pursuant to the notice appellant appeared alongwith Advocate Sadanand D. Vaingankar and pressed for complete information as sought by him. Respondent PIO was represented by his authorized representative. Reply was filed on behalf of PIO on 28/09/2022. PIO was directed by the Commission to file an affidavit pertaining to the status of the information sought by the appellant.
3. Accordingly affidavit dated 30/01/2023 signed by Shri. Rajesh Kumar, PIO, SDPO, Pernem-Goa was filed before the Commission on 31/01/2023, regarding the status of the information. Copy of the

said affidavit was furnished to the appellant. Adovcate Sadanand D. Vaingankar on behalf of the appellant stated that, he is satisfied with the contents of the affidavit and requested the Commission to dispose the matter.

4. It is seen that the status of the information sought by the appellant vide application dated 12/01/2022 has been furnished by the PIO on an affidavit in reply and the appellant after the receipt of the same has requested for disposal of the matter. Hence, the Commission concludes that prayer for information becomes infructuous and no more intervention of the Commission is required in the present matter.
5. Thus, the present appeal is disposed accordingly and the proceeding stands closed.
