### ORDER

- 1. Aggrieved by non furnishing of complete information and non receipt of the order disposing the first appeal within the stipulated period, appellant under Section 19 (3) of the Right to Information Act, 2005 (hereinafter referred to as the 'Act') filed second appeal against Respondent No. 1, First Appellate Authority (FAA), and Respondent No. 2, Public Information Officer (PIO) which came before the Commission on 18/10/2022.
- Notice was issued to the concerned parties and the matter was taken up for hearing. Shri. Tushan Gurudas Kunkolienkar appeared on behalf of the FAA under authority letter and filed reply alongwith enclosures. Smt. Shobhana Uday Chodankar, PIO appeared in person and filed reply.
- 3. During the hearing, appellant vide e-mail received in the registry on 20/12/2022 stated that, he has received the desired information and he is satisfied with the same. Appellant further prayed that the matter may be disposed off.

- 4. Considering the fact that the appellant has received the requested information and he has requested for disposal of the matter, the Commission finds that the prayer for information becomes infructuous and no more intervention of the Commission is required in the present appeal proceeding.
- 5. Thus, the appeal is disposed accordingly and the proceeding stands closed.
