**ORDER**

1. The brief facts of this appeal are that the appellant, aggrieved by non receipt of the information under Section 19 (3) of the Right to Information Act, 2005 (hereinafter referred to as the 'Act') filed second appeal against Respondent No. 1, Public Information Officer (PIO), and Respondent No. 2, First Appellate Authority (FAA), which came before the Commission on 24/11/2022.
2. The concerned parties were notified and the matter was taken up for hearing. During the hearing on 31/01/2023 PIO, Shri. Sandesh Velip appeared in person and filed reply stating that the information sought by the appellant vide application dated 23/08/2022 has been furnished and the appellant has acknowledged the same. PIO requested for disposal of the matter.
3. It is seen that the appellant vide an e-mail sent on 31/01/2023 has submitted that the PIO has furnished the requisite information and he wishes to withdraw the present appeal.

4. Upon perusal of the records the Commission finds that, the information sought vide application dated 23/08/2022 has been furnished and the appellant after receipt of the information has requested for the disposal of the matter, as the information has been already furnished and no any grievance of the appellant is left to be decided. Hence, the Commission concludes that the present appeal needs to be dispose accordingly.
5. Thus, the present appeal is disposed as withdrawn and the proceeding stands closed.
