**ORDER**

1. Aggrieved by receipt of incomplete information, appellant under Section 19 (3) of the Right to Information Act, 2005 (hereinafter referred to as the 'Act') filed second appeal against Respondent No. 1, Public Information Officer (PIO), and Respondent No. 2, First Appellate Authority (FAA), which came before the Commission on 27/12/2022.
2. During the proceeding on 15/02/2023, Smt. Vaishali Pilyekar, L.D.C. appeared on behalf of the PIO and furnished information to the appellant. However, the appellant was not satisfied with the information, hence, the Commission directed PIO to provide for inspection of the relevant records on 21/02/2023. PIO and appellant agreed to carry out the inspection.
3. During the hearing on 06/03/2023, Shri. Sidharaj U. Gauns, PIO appeared in person and stated that he has furnished complete information. Similarly, appellant who was present in person, with his

signature on the appeal memo stated that he has received the information from PIO/ Awal Karkun, office of Deputy Collector & S.D.O., Bicholim Goa and that he is satisfied with the same. Appellant requested the Commission to dispose the matter.

4. The Commission finds that the information desired by the appellant vide application dated 27/06/2022 has been furnished to the satisfaction of the appellant. Hence, the prayer for information becomes infructuous and no more intervention of the Commission is required in the present matter.
5. Thus, the present appeal is disposed accordingly and the proceeding stands closed.
