ORDER

1. The Complainant, Mr. Amar Kantik, r/o. 6/2, Shree Damodar Co-operative Housing Society Ltd., Alto Aquem, Margao, Salcete-Goa vide his application dated 06/12/2022 filed under Section 6(1) of the Right to Information Act, 2005 (hereinafter to be referred as 'Act') sought certain information from the Public Information Officer (PIO), Goa Medical College, Bambolim-Goa.
2. The said application was responded by the representative of the PIO, Dr. Jude Rodrigues, Prof. and Head of General Surgery & I/C of Casualty, Goa Medical College, Bambolim Goa on 13/12/2022 in the following manner:-

"With reference to above application Under Right To Information Act 2005, Received on 13/12/2022, from Mr. Amar Kantik from Alto Aquem, Margao-Goa.

At Point No. III) we cannot provide said information sought by you U/S 8(i) J.

At Point No. II) & IV) transfer to PIO, Dean Office, Bambolim U/S 6(3)."

3. Being aggrieved and not satisfied with the reply of the PIO, the Complainant preferred complaint proceeding before the Commission on 06/01/2023 under Section 18 of the Act, with the prayer to direct the PIO to furnish the information and penalise the PIO for denying the information.
4. Notices were issued to the parties, pursuant to which the Complainant appeared in person on 27/02/2023, the representative of the PIO, Ms. Milita Lopes appeared and sought time to furnish the information, and the matter was posted for compliance.
5. In the course of hearing on 05/05/2023, the representative of the PIO, Ms. Milita Lopes appeared and furnished bunch of documents to the Complainant. Since the information furnished was voluminous in nature, Complainant sought time to scrutinise the documents and the matter was posted for clarification on 09/06/2023.

6. During the course of hearing on 09/06/2023, Ms. Milita Lopes appeared on behalf of the Respondent and submitted that she has furnished all the available information to the Complainant on 05/05/2023 and no further information is available with the public authority.

7. After receiving the information from the PIO on 05/05/2023, the Complainant did not appear for subsequent hearing on viz 09/06/2023 and 30/06/2023. Therefore, I presume and hold that the Complainant is satisfied with the information provided by the PIO, hence the matter is disposed off.
