ORDER

1. The complainant under Section 18 of the Right to Information Act, 2005 (hereinafter referred to as the 'Act') filed complaint against Opponent No. 1, Shri. Dattatray G. Parab, Awal Karkun, Public Information Officer (PIO), Opponent No. 2, Shri. Raghoba S. Shetye, L.D.C., Public Information Officer (PIO) and Opponent No. 3, Shri. Rajaram Yeshwant Parab, Mamlatdar, First Appellate Authority (FAA), which came before the Commission on 02/02/2023.
2. Notice was issued to the concerned parties and the matter was taken up for hearing. During the proceeding on 17/07/2023 complainant filed submission stating that, he is intending to approach the competent authority to redress his grievances into this matter and that he wishes to withdraw the present complaint.

3. It is seen that, the complainant wishes to withdraw the present matter and has sought the permission of the authority to withdraw his complaint. Thus, the Commission grants permission to the complainant to withdraw the present complaint.
