<u>ORDER</u>

- 1. The second appeal filed by the appellant under Section 19 (3) of the Right to Information Act, 2005 against Respondent No. 1, Public Information Officer (PIO) and Respondent No. 2, First Appellate Authority (FAA), came before the Commission on 31/08/2023.
- 2. Pursuant to the notice, appellant appeared praying for the information and filed submission dated 04/01/2024. Shri. Ganesh Barve, PIO appeared in person initially and later Smt. Safira Zaid Shaikh represented the PIO, under authority. PIO filed reply on 23/11/2023 and report of inspection dated 14/02/2024. Smt. Shivani Nadkarni appeared on behalf of FAA, under authority and filed reply on 23/11/2023 and submission dated 14/02/2024.
- 3. During the proceeding, it is seen that, PIO has furnished part information, however, the appellant is praying for the remaining information and inspection with respect to point no. 4 and 5 of his

application. At the same time, PIO agreed to provide inspection to the appellant.

- 4. The Commission, on 04/01/2024, directed the PIO to provide inspection of relevant documents to the appellant. It is seen that, the inspection was carried out on 29/01/2024, as undertaken by the PIO.
- 5. PIO vide report of inspection dated 14/02/2024, submitted that, as per the direction of the Commission, PIO has facilitated inspection and furnished photocopies of the identified information to the appellant, free of cost. Similarly, appellant acknowledged receipt of the information.
- 6. It is observed that, the information desired by the appellant has been furnished by the PIO and the receipt has been acknowledged by the appellant. Thus, there is no need of any further intervention in the present matter.
- 7. Hence, the present appeal is disposed accordingly and proceeding stands closed.
