<u>ORDER</u>

1. The Appellant, Dastageer Mulla, r/o. G-2, Plot No. 99, Near Bhatikar Model High School, Gogol Housing Board, Gogal, Margao, Goa, vide his application dated 23/05/2023 filed under Section 6(1) of the Right to Information Act, 2005 (hereinafter to be referred as Act), sought certain information from the Public information Officer, Sub-Divisional Police Officer, Margao, Goa.

2. The said application was replied by the PIO on 20/06/2023 in the following manner:

- 3. Being aggrieved and not satisfied with the reply of the PIO, the Appellant filed the first appeal before the Superintendent of Police (South), Margao Goa on 26/06/2023, being the First Appellate Authority (FAA).
- 4. The FAA, vide its order, upheld the reply of the PIO and dismissed the first appeal on 25/07/2023.
- 5. Feeling aggrieved and dissatisfied with the Order of the FAA dated 25/07/2023, the Appellant landed before the Commission by this second appeal under Section 19(3) of the Act, with the prayer to direct the PIO to provide the information and to impose penalty on the PIO for denying the information.
- 6. Notices were issued to the parties, pursuant to which, the Appellant appeared alongwith his representative

Shri. Mukundraj Mudras on 04/10/2023, the representative of the PIO Shri. Ditendra B. Naik appeared and placed on record the reply of the PIO. The FAA, duly served, opted not to appear in the matter.

- 7. In the course of hearing on 13/02/2024, the representative of the PIO Shri. Ditendra Naik appeared and submitted that, all the available information has been provided to the Appellant on 20/06/2023. However, the representative of the Appellant raised the queries that he is not provided with the copy of the Station diary, list of Police personnel who visited the house of Smt. Bismillah Mulla on 16/05/2023 and the copy of the details of the transfer of Complaint from Anti Human Trafficking Unit (Woman and Child protection Unit) Margao to the Police Station at Fatorda Goa. The representative of the PIO submitted that he is ready and willing to furnish the information. Accordingly, the Commission directed the PIO to come alongwith the information on the next date of hearing and matter was posted for compliance on 26/02/2024.
- 8. In the course of hearing on 26/02/2024, the representative of the PIO, Smt. Anita A. Kholkar, ASI attached to Fatorda Police Station appeared and furnished (i) Copy of Station diary dated 16/05/2023 (ii) copy of forwarding letter dated 27/05/2023 alongwith the copy of Complaint and (iii) list of Police personnel who visited the house of Smt. Bismillah Mulla on 16/05/2023.
- 9. The representative of the Appellant, Shri. Mukundraj Mudras verified the information provided by the representative of the PIO and submitted that he is satisfied with the information, except for the list of Police personnel. According to the

Appellant, there were five police personnel visited the house of Smt. Bismilla Mulla on 16/05/2023. However, the names of only four Police personnel have been provided to him. Smt. Amita A. Kholkar assured that she will obtain the details and provide the rest of the information within a week. Considering the submission of Smt. Anita Kholkar, the appeal is disposed of with the direction to the PIO to furnish the rest of the information within fifteen days from the date of receipt of the order.
