### **Relevant Facts Emerging from the Complaint**

### **Information sought and background of the Complaint**

- Shri. Brian Fernandes filed a complaint dated 28/12/2025 before the Commission stating that Opponent No. 01 (Respondent PIO/ Dy. Education Officer) failed to furnish information pertaining to PTA activities of Miracles High School, Sanguem, Goa in violation of the order dated 19/11/2025 passed by Hon'ble Commission in Appeal No. 261/2025/SCIC.
- Commission vide order dated 19/11/2025 had directed the Opponent No. 01 to furnish information on PTA activities in respect of three schools within 10 days from the receipt of the order. Accordingly, Opponent PIO furnished information in respect of 02 schools only prompting the Appellant to approach the Commission with the Complaint dated 28/12/2025.

**FACTS EMERGING IN COURSE OF HEARING**

3. Pursuant to the filing of the present Complaint by the Complainant, parties were notified fixing the matter for hearing on 18/02/2026 for which Complainant and Opponent PIO present.
4. At the onset of the hearing itself, Opponent PIO orally submitted that information sought by the Complainant is kept ready and willing to provide the same on 19/02/2026.

**DECISION**

Accepting the oral submission of the Opponent PIO, Commission decided to dispose the complaint with the direction to the Opponent PIO to fully comply with the Commission's order dated 19/11/2025 in Appeal No. 261/2025/SCIC within five (05) days from the date of receipt of this order.
