**ORDER**

1. The present second appeal arises out of the Right to Information (RTI) application dated 04/10/2023 made by the Appellant, Shri. Vilas V. Naik and addressed to the Public Information Officer (PIO) of Village Panchayat Anjuna-Caisua, Bardez-Goa.
2. The PIO has failed to reply the RTI application of the Appellant within the stipulated time period of 30 days under the RTI Act.
3. Consequent upon no response from the PIO, the Appellant preferred first appeal dated 30/11/2023 before the competent authority.

4. The First Appellate Authority (FAA) vide its order dated 02/01/2024 disposed the first appeal and directed the Appellant to collect the information from the court file within 15 days of passing of this order.
5. Being aggrieved with the order of the FAA, the Appellant preferred second appeal vide appeal memo dated 23/01/2024 before this Commission.
6. Notices were issued and matter came up to be heard from 20/02/2024 onwards. Matter could not be heard between February 2024 to September 2024 due to demitting office by the Commissioners and hearings were resumed from September 2024 onwards.
7. During the hearing on 12/02/2025, the Appellant submitted that the PIO through his legal representative furnished him the required information as per his RTI application and therefore he requested this Commission to withdraw his appeal.
8. In view of the above, the present second appeal is disposed off as withdrawn by the Appellant.
  - No order as to cost.
  - Parties to be provided authenticated copies of the order.
  - Aggrieved party if any, may move against this order by way of a Writ Petition as no further Appeal is provided against this order under the Right to Information Act, 2005.
