O R D E R (07/12/2010)

1. The Complainant, Dr. Ketan S. Goveker, has filed the present Complainat praying that information as requested by the Complainant be furnished to him forthwith; that penalty be imposed on the Public Information Officer as per law for giving incomplete information to the Complainant; that compensation be granted for detriment faced by the Complainant for not getting the complete information.

2. The brief facts leading to the present complaint are as under:-

That the Complainant, vide his application dated 21/12/2009 sought certain information under the Right to Information Act ('RTI' Act) from the Public Information Officer ('PIO')/Opponent No. 1. That the opponent No. 1/PIO by providing incomplete information has failed to furnish the information. That the first Appellate Authority also failed to fix the period within which information is to be furnished. Since incomplete information is furnished the complainant has filed the present complaint on the grounds as set out in the Complaint.

3. The Opponents resist the complaint and the written statement of the opponent No. 1 is on record. In short it is the case of the Opponent No. 1 that whatever information was available has been furnished. According to the Opponent No. 1 the2/-

4. Heard both sides and perused the records. It is seen that request of the Complainant is dated 21/12/2009. The reply is dated 20/01/2010 whereby information was furnished. The reply is apparently in time.

During the course of his arguments the Complainant submits that he has received full information and that he is satisfied with the same. He also states that he has no grievance of any sort.
