**O R D E R**

1. This is a Complaint filed by the Complainant Shri Rabindra A. L. Dias against the Opponent praying to take cognizance that Opponent had not abided as per section 19(e) of RTI Act; for penalizing the Opponent and also for compensation and other reliefs as mentioned in the Complaint.

2. It is the case of the Complainant that he had filed an Appeal as the Public Information Officer of the Office of Mamlatdar of Salcete, South Goa District had not abided as per the Indian Evidence Act, 1872 and intentionally made available certified copies of unauthorized copies. The Complainant had filed Appeal before First Appellate Authority i.e. Opponent herein. That the Opponent refused to hear/dispose off the Appeal within the stipulated time under section 19(6) of the R.T.I. Act and hence the Complaint on the grounds as set out in the Complaint.

3. The matter was posted today. The Complainant appeared in person and submitted an application stating that First Appeal in Election matters lies with the Collector the Additional Collector and as such the said Complaint filed may be treated as withdrawn/cancelled which has been scheduled today. Notice was issued to the Opponent. However, he remained absent.

4. Since the Complainant wants to withdraw the Complaint his request is to be granted and he be permitted to withdraw the Complaint. Hence, the following Order:

The Complaint is disposed off as withdrawn.
