**ORDER**  
(23/02/2012)

1. The Complainant, Smt. Pamita Azavedo, has filed the present complaint praying that opponent be directed to immediately furnish the information sought by the complainant and that penalty be imposed on the PIO.

2. The brief facts leading to the present complaint are as under :  
The complainant had filed the complaint bearing No.61/SIC/2011 and the same was disposed by the Commission allowing the complaint and the opponent was directed to furnish the information within 30 days from the date of receipt of the order. That the opponent in terms of letter dated 15/9/2011 addressed to Sub Divisional Engineer, Electricity Department, Sub Div.IV Candolim and directed him that Hon'ble Commission has directed to refer the entire subject matter with relevant case papers to the Police for further investigation in the matter under intimation to the Complainant within 15 days from the date of appearing before

the Commission i.e. on or before 21/09/2011. That the copy of the said letter was also endorsed to the complainant. That the complainant took up the matter with the said Sub Divisional Engineer with a request to furnish her with a copy addressed to the Police Department alongwith all the relevant documents submitted to the police. That till today though over 90 days have lapsed since the letter dated 15/9/2011 has been received by Sub Divisional Engineer at Candolim, the complainant has not been furnished with the required information. Hence the Complainant filed the present complaint.

In pursuance to the notice issued the opponent along with representative Shri Kashinath Shetye remained present.

3, Heard both sides.

During the course of his arguments, the representative of Complainant, Shri C. S. Barretto states that required information is furnished and that the complainant has no grievance of any sort. He states that he may be permitted to withdraw the complaint .

4. Since whatever information has been furnished, no intervention of this Commission is required. Hence I pass the following order.:-

### **ORDER**

No intervention of this Commission is required. The complaint is disposed off as withdrawn.

The complaint is accordingly disposed off.
