O R D E R

The present second Appeal is directed against the common order dated 13/02/2008 passed by the Respondent No 2 in first Appeals No. 04, 05 and 06/2008 under section 19(3) of the Right to Information Act 2005 (for short the Act). By a separate application, the Appellant has prayed for the condonation of delay of 14 days in preferring the present Appeal on the ground that his legal advisor was out of station and has arrived in Goa on 23/05/2008. Being so, before we discuss the merits of the Appeal, it is necessary to see whether the Appellant has made out the case for the condonation of delay. ...2/-

2. According to the Appellant there is a delay of 14 days, which has caused due to non-availability of his legal advisor in station. The Appellant has not produced any letter or proof that his legal advisor was out of Goa. He has not indicated the details of its legal advisor such as name, address etc. The application for condonation of delay is also not support by an affidavit.

3. We are, therefore, not satisfied with the reasons advanced by the Appellant and no case is made out by the Appellant to condone the delay. Hence, we dismiss the Appeal being barred by law of imitation.
