## **JUDGMENT**

(Per Afonso Araujo)

The Appellant on 29.05.2008 sought information under the Right to Information Act, 2005 which pertains to his application dated 14.12.2007 for his objection to grant permission for a Beat Show. The Respondent No. 1 on 09.06.2008 called the Appellant to make payment and provided order of permission dated 26.12.2007 and the application of the organizer of the beat-show dated 05.12.2007 and on 23.06.2008 transferred under section 6(3) of the RTI Act the request of the Appellant pertaining to item 4, 5, 6 and 7 of the letter dated 29..05.2008 to the Police Inspector, Vasco Police Station. The Police Inspector, Vasco Police Station on the letter dated 03.07.2008 addressed to the Respondent No. 1 replied stating that no record is maintained at the Police Station regarding information at point 4, 5, 6 and 7 in the application of the Appellant.

2. The Appellant preferred First Appeal and by order dated

23.10.2008 the First Appellate Authority-Respondent No. 2 directed the

Respondent No. 1 to provide the information within one week. As the

Appellant did not obtain the information required, preferred this Second

Appeal. From the records it appears that the information at point 1 and 2

was provided by the Respondent No. 1 and at point 4 to 7 it was

transferred to the Police Inspector, Vasco Police Station who by letter

dated 03.07.2008 stated that no record is maintained at the Police

Station. The First Appellate Authority in his order directed the

Respondent No. 1 to provide the information at point 4, 5, 6 and 7 when

the Respondent No. 1 already has transferred this request to the Police

Inspector, Vasco Police Station.

3. Since the Public Information Officer to the Public Authority of Vasco

Police Station is Superintendent of Police (South), the proper course

would be to direct the Superintendent of Police (South), Margao to

provide the information at point 3, 4, 5, 6 and 7 to the request dated

29.05.2008 within the period of thirty days from the date of receipt of this

order and report compliance on 10.11.2009. A copy of this order and the

application dated 29.05.2008 to be forwarded to the Public Information

Officer, the Superintendent of Police (South), Margao.
