This Commission has held the view in Complaint No. 25/2006 that the information under the Act can be sought only by the natural person and not by legal person like companies, firms Associations etc and the same has been reiterated in subsequent decisions. Being so, the application dated 03/04/2007 of the Appellant itself was not maintainable under the Act and consequently, the appeal is also not maintainable. Therefore, on this ground alone, we dismiss the appeal being not maintainable.
