CHAPTER - I

INTRODUCTION

Information is power and provides people with the knowledge to demand political, economic and social rights from their Governments. The Right to Information is a tool in the hands of people.

The Right to Information Act, 2005 (Act No. 22 Central Act, 2005) was notified in the Official Gazette of India on 21st of June, 2005, Sections 4(1), 5(1), 5(2), 12, 13, 15, 16, 24, 27 & 28 of this Act came into force with effect from the date of notification and the remaining provisions came into force on the 12th of October, 2005. The Act extends to the whole of India except Jammu & Kashmir. It is applicable to Constitutional Authorities, bodies established or constituted by an Act of the Parliament, it also applies to bodies owned, controlled or substantially financed by the Government direct or indirect.

2. The main objective of the Right to Information Act, 2005 is to ensure transparency and accountability in the working of every public Authority in the country and to contain the corruption. The Act mandates a legal-institutional frame work for seeking out a practical regime of right to information for every citizen to secure access to information held by or under the control of Public Authorities. This is a path breaking legislation that enables the country to break away from the colonial legacy of secrecy which is anathema to a democratic system. Setting up of Information Commission at the Central and State Level to ensure the effective implementation of the Right to Information regime in the country is one of the key provisions of the Act.
3. The State of Goa had also enacted the Right to Information Act in the year 1997. However, the scope of the said act was limited in the sense that the information could be sought only to subserve the public purpose. Whereas in the RTI Act, no reasons are needed to be given for seeking information.

CHAPTER - II

CONSTITUTION OF THE GOA INFORMATION COMMISSION

The Goa State Information Commission was constituted under Section 15(1) of The Right to Information Act, 2005, consisting of the State Chief Information Commissioner and one State Information Commissioner vide notification dt. 02-03-2006. The details of names of the State Chief Information Commissioner and the State Information Commissioner with date are given below:-

I STATE CHIEF INFORMATION COMMISSIONER

- 1) SHRI A. VENKATARATNAM, 21-03-2006 to 08-03-2009
- 2) SHRI M. S. KENY, 21-10-2009 to date.

II STATE INFORMATION COMMISSIONER

- 1) SHRI G. G. KAMBLI, 21-03-2006 to 01-01-2009
- 2) SHRI AFONSO ARAUJO, 04-03-2009 to 02-08-2010.

The Goa State Information Commission consists of (a) The State Chief Information Commissioner and (b) one State Information Commissioner.

2. The terms and conditions of service of the Chief Information Commissioner and the State Information Commissioner are laid down under Sec. 16 of the Right to Information Act, 2005. The Chief Information Commissioner enjoys the salary and perquisites of a Central Election Commissioner, who in turn enjoys the salary and perquisites of a Supreme Court Judge. These are laid down in the Supreme Court Judges (Salaries and conditions of service) Act, 1958 as amended from time to time. The State Information Commissioner enjoys the status, salary and perquisites of the Chief Secretary of the State Government.

3. The Goa State Information Commission till date has not been provided with suitable accommodation by the Government. Commission is still functioning at its old premises admeasuring 78.29 sq. mts. on the ground floor of Shrama Shakti Bhavan without adequate and basic amenities. The Government is making successful efforts to provide Commission with suitable accommodation on priority basis.

4. The RTI Act under Sec. 16(6) enjoins upon the State Government to provide The State Chief Information Commissioner and The State Information Commissioner with such officers and employees as may be necessary for the efficient performance and their functions and their service and the salaries and allowances payable to and the terms and conditions of service of the officers and other employees appointed for the purpose of this Act shall be such as may be prescribed. 20 posts have been sanctioned by the Government. So far Government has filled 15. A list of posts filled is as under:

Besides the above regular employees, there are 5 PETS employees i.e. one Jr. Steno, one L.D.C. and 3 Drivers.

Nodal Department – The RTI Act, 2005 is administered by the Department of Information and Publicity at the State Government level. The budget of the Goa Information Commission is also provided in the same Department, as Grants-in-Aid.

5. An amount of Rs. 127.00 lakhs has been provided for financial year 2009-10 as Grants-in-Aid to Goa State Information Commission.

Centrally Sponsored Scheme

4.4 Under the Centrally Sponsored Scheme on Strengthening Capacity Building and Awareness Generation for effective implementation of the RTI Act. The Department of Personnel & Training, Government of India had disbursed an amount of Rs. 350 lakhs for awareness generation during the year.

4.5 The fund received for awareness generation was spent on printing of 25,000 RTI booklets through The Goa Government Printing Press and distributed free of cost to the citizens of the State through Village Panchayats/B.D.Os/Municipalities and other Public Authorities.

CHAPTER - III

INFORMATION REGARDING THE APPLICATION RECEIVED BY THE PUBLIC AUTHORITIES

As per Section 6(1) of the Right to Information Act, 2005 a total of 32,147 applications were received by the State Public Information Officers of various public authorities during the year 2009. 805 applications were pending from previous year. Thus total of 32,147 applications needed to be considered for giving information during 2009. It is seen from the applications of 2009 under Right to Information Act, 2005 that the maximum number was received by the Panchayat Department. That Department had received 6001 applications. The top five Departments according to the number of applications received are as follows:

2. Information Regarding giving information to the applicants.

In 2009 out of 32,147 applicants, 29,040 got the information.

3. On account of the Information supplied by the State Public Information Officers to applicants total fee of Rs. 4,23,982.00 has accrued with the Government.

CHAPTER - IV

FUNCTIONS AND THE POWERS OF THE INFORMATION COMMISSION

The functions and the powers of the Commission are mainly laid down in Sections 18, 19, 20 & 25 of the Act.

4.1 Complaints and Appeals to the Commission.

The Information Commission has the Original Jurisdiction to receive and inquire into Complaints under Sec. 18 and Second Appellate Jurisdiction under Section 19(3) to receive appeals against the decisions of public authorities. During the year under report, the Commission had received 140 Complaints, 221 Second Appeals. When complaints on non-disposal of requests for information by the State Public Information Officers (SPIO's) were received, the procedure adopted by the Commission was to instruct the concerned SPIO to dispose of the request for information in accordance with Section 7 of the Right to Information Act at once and to report Compliance to the Commission. The Public Information Officer/appellate authority concerned was summoned for a hearing when satisfactory action was not taken on the request. In the case of Complaints of other nature and appeals u/s 19(3), copies of the complaints/appeals were sent to the public authorities for their reports. Prompt action had been taken on all the complaints and appeals received by the Commission in terms of the Goa State Information Commission (Appeal Procedure) Rules, 2006. The Commission held hearing on all working days of the week even in the evening session with a view to dispose of the complaints/appeals. During period of report 74 complaints and 125 appeals were finally disposed of, details of which are at Annexure.

Lapses on the part of Public Information Officers

4.2 Section 20 of the RTI Act empowers the Central and State Information Commissions to impose penalty and for recommending disciplinary action against the PIO for the following lapses:

- i) For refusing to receive an application or not furnishing information within the prescribed time limit without reasonable cause.
- ii) For malafidely denying the information.
- iii) For knowingly giving incorrect, incomplete or misleading information.
- iv) For destroying the information, which was the subject of the request.
- v) For obstructing in any manner in furnishing the information.

4.3 During the year of report the Commission had initiated and completed action u/s 20(1) of the RTI Act, 2005 and had imposed penalty amounting to Rs. 30,000/- in four cases. Statement showing details of cases in which the commission had imposed penalty is at Annexure IV, likewise the Commission had awarded a total amount of Rs. 15,000/- as compensation u/s 19(8)(b) of the RTI Act during 2009 details of which are at Annexure V.

Centrally Sponsored Scheme

4.4 Under the Centrally Sponsored Scheme on Strengthening Capacity Building and Awareness Generation for effective implementation of the RTI Act. The Department of Personnel & Training, Government of India had disbursed an amount of Rs. 3.50 lakhs for awareness generation during the year.

4.5 The fund received for awareness generation was spent on printing of 35,000 RTI booklets through The Goa Government Printing Press and distributed free of cost to the citizens of the State through Village Panchayats/B.D.Os/Municipalities and other Public Authorities.

CHAPTER - V

RECOMMENDATION OF STATE INFORMATION COMMISSION TO GOVERNMENT

1. The State Government should develop adequate infrastructure for Information Commission and strengthen them by providing suitable accommodation to the Commission on priority basis for its effective functioning.
2. The State Government should make adequate budgetary provision for development of public awareness programmes on RTI Act and implement such programmes on regular basis.
3. The State Government should ensure that provisions of Section 4 of the RTI Act are implemented by all the public authorities also all public authorities should update their records, improve their infrastructure etc. within their resources by making provision in their budget. All Public Authorities should complete the process of digitization at the earliest and their controlling Departments at State level should lay down a detailed road map for this purpose with time bound programme and implement the same on priority basis.
4. In the last report Commission had recommended constitution of a State Level Committee under the Chairmanship of Chief Secretary with the Secretary of the Commission as one of the members of the Committee & two separate sub-committees to be constituted for the local self Government i.e. Municipalities and Panchayats to monitor the implementation of Act on priority basis as the applications seeking information have increased considerably and to advice on the evaluation of effective implementation of RTI across the Goa State.
5. In the last report, Commission had also recommended to Government to conduct/organize training programmes specially to PIO/APIO/FAAs in a phased manner to achieve 100% result and also to take the work of indexing and cataloging of the records on war footing and make the list available on the website. But such an effort is not very much seen.
6. Any other rules or press notes on R.T.I. should be well publicized similarly guidelines on this subject also be published.
7. To include RTI as one of the subject at the Higher Secondary level and above.
8. To appoint PIOs and First Appellate Authorities wherever it has not been done.
9. To issue instructions/guidelines to all the Public Authorities to appoint an Officer of appropriate level to represent First Appellate Authority whenever they are unable to remain present in person as the Commission has observed that very low level Officer represents the Appellate Authorities who are unable to defend the interest of the First Appellate Authorities.
10. To ensure that the Public Information Officers/First Appellate Authorities do not seek adjournments of the hearing.
11. Every public authority should send necessary material to its administrative Ministry/Department soon after the end of the calendar year so that the Ministry/Department may send the consolidated information to the Commission for incorporating the same in its Annual Report.

12. In many cases the First Appellate Authorities do not give a decision or they give an ambiguous decision about giving information. The purpose of First Appeal is to reduce the number of Second Appeals to the Commission by giving information to the applicant at the level of the Public Authority itself. But the First Appellate Authority have a tendency to give a decision to give information rather than to ensuring that information is actually given. It should be noted by Government that for these reasons the number of appeals is increasing with the Commission.
13. The State Government should integrate RTI with all flagship programmes, in the same way as has been done in case of NREGA.
14. The State Government should ensure that all Panchayats have responsible Public Information Officers.
15. The State Government should restructure their work process so as to make them compatible with RTI Act.
16. In many cases PIOs do not give information in time so number of Complaints increase under Sec. 18. The purpose of First Appeal is to reduce the work of Commission i.e. by giving information to the applicant at the level of the Public Authority itself. Government should therefore make it clear to all Public Information Officers that if Complaints come u/s 18(1), penalty can be imposed.
17. Now, it is practice by most Government servants that they file Appeals/Complaints in their name to the Commission. Commission therefore recommends to Government in such cases they should issue the necessary administrative instructions to all H.O.D. to seek written permission from the concerned Head of Office/Head of Department before putting any appearing before Commission in Appeal/Complaint case.
